

STUDENT'S PREVIOUS JUDICIAL RECORD DECLARATION FORM

HUMAN RESOURCES, COMMUNICATIONS AND LEGAL AFFAIRS DIRECTORATE

Before being hired, all applicants (hereinafter referred to as the "Declarant") must declare whether they have a previous judicial record in Canada or abroad, unless they have received a pardon.

All persons who carry out functions or practice their profession at the Montreal West Island Integrated University Health and Social Services Center (hereinafter referred to as the "Declarant") must declare whether they have a previous judicial record in Canada or abroad, unless they have received a pardon.

All Declarants must fill out the sections of this form that are applicable. To have their files reviewed by the Montreal West Island Integrated University Health and Social Services Center, Declarants must attach to this form any document they consider pertinent (indictment, judgement or record of proceedings of the decision of the Court, recognizance, order, application for pardon, their written comments).

NOTE

- All Previous Judicial Record Declaration Forms will be returned to the Declarant if the form is incomplete or not signed;
- Any false declarations made by the Declarant may result in the application being rejected or the imposition of disciplinary or administrative measures, respectively;
- Any refusal from the Declarant to cooperate with the Montreal West Island Integrated University Health and Social Services Center may result in the application being rejected or the imposition of disciplinary or administrative measures;
- The Institution can only take into account previous judicial records that are directly related to the functions or profession to be practiced or being practiced within the Institution.
